2020 Riggs Symposium



The Section on International and Comparative Administration (SICA) of the American Society of Public Administration is seeking abstracts and/or fully-formed panels for the <u>seventh annual Fred Riggs Symposium</u>, to be held in Anaheim, California on April 3, 2020.

Our question for this year's symposium – Does Democracy Deliver? – is tied to the overall ASPA conference theme: 2020 Vision for Politics, Policy and Administration.

Over the last quarter-century, policymakers have been urged to redesign administrative systems so that they advance liberal democratic values. Emphasis has been put on design principles like public control, checks and balances on agency action, transparency, decentralization, and community engagement. In some contexts, these principles have been implemented without having formal democracy. Simultaneously, scholars have noted growth in autocracy and a decline in democratic governance around the world. This has led many policymakers and scholars to raise a set of related and critical questions:

- Is democracy necessary to generate effective service provision and establish governmental legitimacy?
- What kinds of organizations and institutional designs are necessary to produce public services?
- Do democratic systems control corruption and maintain a strong merit-based public service more effectively than non-democratic systems?
- To what extent is liberal democratic governance necessary to improve state capacity?

Four decades of SICA leadership

SICA was created out of the merger of ASPA's International Committee and the independent Comparative Administration Group (CAG). CAG, a group of self-selected academics and practitioners that coalesced in the late 1950s and early 1960s, consisted of a loosely knit group of scholars interested in furthering the development of the field of comparative public administration in the U.S. and abroad. Many CAG members were active in development administration abroad. living for substantial periods in country working with national and sub-national governments and groups, and then writing about their experiences and knowledge gained through participant observation.

2020 Riggs Symposium



The aim of the 2020 Riggs Symposium is to explore these questions, and consider how specialists in public administration should respond to the apparent crisis of liberal democracy. We seek papers and panels that address this topic in any national or comparative context. Papers might evaluate criticisms of liberal democratic governance, examine specific cases of policy reform or policy failure that relate to aspects of liberal democratic governance, or challenge us to reconsider assumptions about the desirability or features such forms of governance.

Individual Paper Proposal: Please submit an abstract not exceeding 300 words, your paper title, and your affiliation and contact information.

Panel Proposal: Please submit the panel title along with the titles of 3-5 papers and the paper author names, affiliations, and contact details. Each panel submission must also include the paper abstracts for each panel. Each abstract should not exceed 300 words.

All abstracts and panel proposals must be submitted via the ASPA website. Please name your submission with an indication of 'Riggs Symposium/ SICA' and select the Riggs Symposium from the options when you submit through the ASPA website. The submission deadline is October 4, 2019. Notice of abstract acceptance will be given by mid-December, 2019.

Renowned scholars including Fred Riggs, Ferrel Heady and Donald Stone were mainstays of CAG. CAG received Ford Foundation grant support to conduct research and publish a series of occasional papers in the 1960s largely through the efforts of Riggs, Heady and Clarence (Clancy) Thurber at Ford, SICA was created in December 1973 with Fred Riggs serving as the first chair. Since this time a long list of distinguished scholars and practitioners have served as SICA Chair and on the Section's Executive Committee.

Interview series: Naim Kapucu

Professor Kapucu, thank you for accepting our invitation for SICA's Newsletter interview series! Congratulations on your achievements! The goal of this interview is to inform our members about your insights on the field, and share information about your successful endeavors.

⇒ The interest in global public administration seems to be growing. Why do you think that is?

Globalization was a substantial challenge for public administration as an academic field as well as practice of implementing public policies worldwide. It also provided opportunities for public administration as well. I always emphasize policy and administration integration as it nicely captured in "vision without execution is hallucination" quote. Major policy problems such as sustainability, resilience, human security cannot be addressed without international collaborative efforts. We also have opportunities to learn from others globally as we learn more about domestic policy problems. Almost all the states are interested in efficient, equitable, just implementation of public policy and public programs. High level of public performance, accountability, rule of law, strong civil society, and other core elements of good governance are also critical for public administration. Furthermore, good governance is no longer a concern that is unique to a particular state in any geographic region of the world. In a world of increased interdependence, good governance is increasingly a concern of the global community of states and of international organizations. It would be a mistake to assume, for example, that the problems of public administration that occur in non-OECD countries are so different from those of developed countries. Contexts in which remedies to those problems are sought may differ, but the issues and policy problems themselves are embedded in public administration, whether they are about legitimacy, efficiency, honesty, or transparency and accountability, recruitment and retention of talented officials, excessive bureaucratization and red tape, and other core elements of effective public policy and governance.

The comparative global approach is rich, still, relatively under explored territory for public administration. We have much to learn from other nations. What they have done, where they have succeeded and failed, will not have direct applicability to our context, but should be suggestive, if we can work out the relationships between structure, opportunities, reforms, and outcomes. Any steps we can take in this direction will benefit public administration as a field of study and practice. We have observed several training programs provided practitioner public administrators in different countries by academic institutions, international associations, and United Nations training programs. We also have observed substantial increase in academic exchange programs for students and scholars globally. I am hopeful that this will help tremendously the practice and scholarship of public administration.

⇒ What do you think will change about the internationalization of public administration in the next five years?

It is hard to provide a concrete response to this question but I can at least mention my wishes for global public administration. We need to collectively address as part of comparative public administration, the governmental, administrative, and political systems of both developed and developing countries with a focus on political systems and their manifestation in administrative systems. We also need to highlight the impact of the context including the culture to the administration of public policies in addition to the structures, behaviors, and processes of public administration in a comparative perspective.

Interview series: Naim Kapucu

Particular emphasis needs to be put on exploring the role of public management systems within the wider political and democratic frameworks in which they function. Based on our accomplishments so far, we need to engage global public administration community in academic exchanges (for both students and scholars/educators), collaborative scholarships, which include joint conferences and workshops, joint training programs for public administrators, and efforts to learn innovative public administration practices globally. If we successfully do these in the next couple of years, the success will not only contribute to global public administration, but also lessons learned will help domestic public administration theory and practice.

⇒ How did you first get involved with SICA and what do you like most about this community?

I am a member of ASPA since 1996. I have never missed an ASPA annual conference since then. The first section of ASPA I engaged was SICA. During my PhD years at the Graduate School of Public and International Affairs (GSPIA) we received substantial emphasis on international affairs as well as development administration. The group is probably the most diverse in ASPA as well as the most collegial. My favorite activities of ASPA annual conferences are Riggs symposium and SICA meetings. Many of my friends in the section were instrumental for my professional development over the years. I have participated in several research and training activities globally. SICA members are my go-to people when I need an advice. I did develop and taught a course at the School of Public Administration at the University of Central Florida. Most of the resources in the course come from the members of SICA.

⇒ What advice would you like to share with SICA members in terms of advancing global perspectives on public administration?

I recommend curiosity, interest, and openness in learning from colleagues and friends in other part of the world. Learning from others will help us personally and professionally and will make us better people. When I was invited to two universities in China in 2012 during my sabbatical year, I was a bit hesitant since I have never been in the county and experienced the culture and daily life. Lucky enough, the both universities (Tongji in Shanghai and Xian Jiao Tong in Xian) asked me to train graduate students, post docs, and junior faculty on network analysis and applications of it in emergency and crisis management. The topic I am passionate about. I spent about a month during the summer 2012. I am glad that I accepted the invitation. I am a frequent visitor of the country and the universities now. I also visited six countries during my sabbatical instead of going to one university. That was also a great opportunity to learn and expand my network with scholars in global public administration community.
